This is for the information of all parents, staff and stakeholders of DAV Public School, NTPC/TTPS, Talcher, Angul, DAV Higher Secondary School, NTPC/TTPS, Talcher, Angul and DAV Talcher Thermal High School, Talcher, Angul that on request of NTPC authorities, the above three schools have been functioning smoothly in the premises of NTPC Limited, TTPS, Angul in accordance with the MOU signed between the DAV College Trust & Management Society and NTPC Limited since April, 1996.

In the mean time the authorities of NTPC Ltd. have served an advance two years notice period vide letter No.1027 dated 28.04.2021 for the closure of the above three schools w.e.f. 30th April, 2023 on the ground of "impending closure of Talcher Thermal Power Station (TTPS)".

The DAV authorities have put their utmost efforts for continuance of the schools and the matter was also discussed in the LMC. In view of the closure of the TTPS, the schools functioning in the NTPC premises have no other alternatives to continue. Hence we will be compelled to close the schools on the date notified by the NTPC authority.

Under the circumstances the DAV organisation informs all the parents, staff members and stakeholders in advance that the above three schools will be closed w.e.f. 30.04.2023 and all are requested to take appropriate steps accordingly. However, the examinations of the affiliating bodies scheduled beyond 30.04.2023, if any, shall be conducted in those campuses without any hindrance to the students.
